Pursuant to Regulation 30 read with Schedule III Part A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that team Directorate General of Goods and Service Tax Intelligence (DGGI), Jaipur Zonal Unit, Jaipur conducted survey of the Unit on 28.08.2025 and issued Seizure Memo (GST INS-02) of various records of the Company. The investigation of seized records shall be done by them in due course of time.

The DGGI Team has not issued any Show Cause Notice or Demand Notice to the Company. The Company has deposited as sum of Rs. 1.50 (Rupees One Crore -Two only) on the basis of Team direction in respect of ascertaining of GST Tax Liability and interest thereon subject to investigation of the seized records.

On being notified of certain procedural and technical discrepancies, Company has voluntarily remitted Rs 1,20,89,548/- along with the applicable interest of Rs. 29,10,454/- For the findings, Company is evaluating further course of action & necessary disclosures will be made at relevant stages of adjudication.

The Company has fully cooperated with the authorities, implemented corrective actions, and further strengthened its compliance framework.
